### Set Up

- Upon arrival, please check in at the SCIO Farmers Market info tent (8<sup>th</sup> Street across from Nikki's Nex 2 New). The onsite manager will arrive at least 1 hour before the start of the market. All vendors must be set up by the Market start time and stay for the entire market duration.
- **Saturdays:** 7am to 8am. Craft sale is 8am to 2:00pm.  
**Wednesday:** 8am to 9am. Craft sale is 9am to 3pm.
- You will be allowed to drive up on the north and south sidewalks to unload and then exit onto Ontario Ave. **No vehicles will be allowed to enter the park 15 mins prior to the market start time.** Please park your vehicles in the Maritime Ins. parking lot on Saturdays.

### Waiver

The undersigned agrees to become a participating vendor at the Sheboygan Farmers Market at Fountain Park on 8<sup>th</sup> Street, Sheboygan, WI for the term of specified days. By signing this contract I agree to the following terms and conditions:

- I the vendor will release SCIO and the City of Sheboygan from any liability whatsoever for theft, damage, injury, litigation, prosecution, illegal sales, practices or loss of any kind associated with the Farmers Market. SCIO is not responsible for any lost, stolen or broken merchandise.
- Vendors are responsible for their own tables, chairs and canopies. SCIO will not be responsible for any lost, stolen, or broken merchandise.
